Dr Subrata Saha is presently the Chair of the Bioethics Committee of IFMBE. He also Chairs the Ethics Committee of the Biomedical Engineering Society (BMES) and he is a member of the Education Committee of the society. Dr. Saha is a member of the Board of Governors of the IEEE Society on Social Implications of Technology (SSIT). Dr. Saha is the Founder of the Southern Bioengineering Conference and organized the first, fifth, eighteenth, and twenty-second conferences of this series. He also founded the International Conferences on Ethical Issues in Biomedical Engineering and Organized all previous seven conferences in this series. In April 2015, he organized the eighth International Conference on Ethics in Biology, Engineering, and Medicine, that was co-sponsored by IFMBE.

Dr. Saha is a Fellow of AIMBE, ASME, BMES, and NYAM. He has been a faculty member at Yale University, Louisiana State University Medical Center, Loma Linda University, University of California at Riverside, Clemson University, Alfred University, and SUNY Downstate Medical Center. He has

published over 125 papers in Journals, 350 papers in conference proceedings, and 120 abstracts. His research has been supported by the National Institute of Health, National Science Foundation, and many other private foundations and industry.
